- A minimum of 90 minutes of direct, explicit, and systematic reading instruction will be provided to students in kindergarten through Grade 2.
- Kindergarten through grade 2 students will receive small group, differentiated instruction to help them achieve the Pennsylvania Core Standards for English Language Arts.
- Mathematics instructional material will be aligned to meet Pennsylvania's Core Standards for Mathematics.

Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:

Provide parents with frequent reports on their child's progress. Specifically, the school will provide reports as follows:

Title 1 schoolwide progress reports will be distributed tri-annually to all students. Reports will be distributed in November 2020, January 2021 and June 2021. Depending upon the child's grade level reports will include student data from Benchmark Literacy, DIBELS Benchmark Assessment System, Study Island Benchmark Reading and Mathematics.
